Whereas: Holy Scripture reveals that all humankind is made in the image of God, blessed

by God, and declared "good" by God (Genesis 1:26-31); and

Whereas: The 2018 Synod of the Moravian Church, Northern Province affirmed that

persons of all gender identities shall be supported and affirmed by being allowed to celebrate their lives as individuals, couples, and families within the bounds of

the church (R&E 2018, pg. 17-18, R. 21-26); and

Whereas: The 2018 Synod of the Moravian Church, Northern Province encouraged pastors

and church leaders to engage in training and education related to the

understanding and care for persons of all gender identities (R&E 2018, pg. 17-18,

R. 21-26); and

Whereas: The mission statement of the Northern Province (as found on the Moravian

Church Northern Province website) states: "The Northern Province of the Moravian Church in America equips people and congregations to be agents of God's transforming love in the world. No matter who you are or how you identify,

you are embraced and affirmed by God's expansive love;" and

Whereas: An understanding of gender identities and issues as they relate to matters of faith

and church life may still be confusing for many; and

Whereas: Trainings on matters of gender identity such as those led by the Bradbury Sullivan

Center (www.bradburysullivan.org/educationinstitute) are available and have been

utilized by some church leaders; therefore be it

Resolved: (4) The 2023 Synod of the Moravian Church Northern Province urges the

Provincial Elders Conference to research the topic of gender identity and faith life, and to discover or create training material that will be required by all Northern Province clergy, and strongly encouraged for all other tiers of church

leadership;

and be it further

Resolved: (5) The 2023 Synod of the Moravian Church Northern Province encourages the Provincial Elders Conference to task appropriate committees or staff to make

the Northern Province's mission statement more widely known by both our

congregations and the general public.

Re: Prioritizing Accessibility in our Congregations and Church Buildings

Whereas, The inclusion and empowerment of individuals living with disabilities within

our congregations and communities is important to more fully living out the

love with which Christ calls us to live, and

Whereas, ministry should not just be to people with disabilities, but with or alongside

people who have disabilities, and

Whereas, many people living with disabilities struggle to feel welcomed and accepted

into places of worship and overall faith communities, and

Whereas, Universal Access refers to creating environments, programs, and services that

respond to the needs of the widest population range possible, enabling persons with varying abilities and ages to access the physical environment on an

equitable basis, and

Whereas, some of our congregations struggle to create cultures that are empowering and

uplifting to individuals and families touched by disability, and

Whereas, many of our current church buildings create physical barriers for individuals

living with disabilities, and

Whereas, being truly inclusive goes beyond physical spaces, and other aspects such as

sensory modifications, intellectual needs, and alternative communications

must be considered, therefore be it

RESOLVED: (6) The 2023 Synod of the Moravian Church Northern Province urges the

Provincial Elders Conference to research the topic of all barriers to full accessibility including but not limited to physical, mental, emotional,

intellectual, learning, developmental, or sensory limitations; and be it further

RESOLVED: (7) The 2023 Synod of the Moravian Church Northern Province urges the

Provincial Elders Conference to distribute current best practice materials related to full accessibility, that goes beyond our physical spaces, recognizing that those with lived experience are often our best resources. Examples of best

practice materials include those developed and made available by You

Belong, a recognized Emerging Ministry, through its website, https://www.youbelongwi.org/; and be it further

RESOLVED:

(8) The 2023 Synod of the Moravian Church Northern Province encourages all congregations within the Moravian Church Northern Province to examine their facilities and overall operation, being mindful of all barriers to full accessibility, and to develop a plan leading toward ever-improving accessibility, and be it further

(9)The 2023 Synod of the Moravian Church Northern Province charges the PEC to commit to a policy whereby accessibility best practices will be implemented at all events and gatherings they plan, support, or endorse, and that activities which do not comply with accessibility best practices through reasonable accommodations will not be permitted, and materials which do not comply with accessibility best practices through reasonable accommodations will not be used at those events and gatherings.

And be it further

(10) The 2023 Synod of the Moravian Church Northern Province directs the PEC

to form a task force to:

- 1. Provide information and guidelines regarding accessibility best practices to those facilitating events and gatherings the PEC plans, supports, or endorses.
- ensure compliance with accessibility best practices through reasonable accommodations at events and gatherings the PEC plans, supports, or endorses.

Re: Strengthening Youth Impact

Whereas, Youth are significant members of our District congregations, and;

Whereas, "Don't let anyone look down on you because you are young, but set an example for the believers in speech, in conduct, in love, in faith, and in purity" 1 Timothy 4:12 (NIV) and;

Whereas, The youth of the Moravian church believe their voices make a significant impact on the church, and;

Whereas, The youth of the Moravian Church seek to have their insights and vision acknowledged, and;

Whereas, There are more than six youth and young adult Northern Provincial Synod delegates in attendance today, and;

Whereas, There is currently no designated Provincial or District Youth and Young Adult minister and or ministries,

Therefore, be it

RESOLVED: (9) The 2023 Synod of the Moravian Church Northern Province urges The Provincial Elders Conference to establish a Provincial Youth Council composed of one youth and/or young adult representative from each of the Northern Province Districts, two youth and/or young adult representatives at large, and two adult mentors, one of which being an ordained or licensed lay pastor, selected in conjunction with the PEC, and;

Whereas, The youth and young adults in attendance at the 2023 Synod of the Moravian Church Northern Province have felt welcomed and valued, yet experience passive reception to their input, vision, and spiritual insights,

Therefore, be it

RESOLVED: (10) The 2023 Synod of the Moravian Church Northern Province urges the PEC, the District Boards, and local congregations to cultivate a stronger committed relationship between the youth and the people called to be the mentors, leaders, and role models of our church. This relationship will thrive through communication, conversation, and idea development in communion with one another, youth participation in local church boards, committees and ministries, and in participation with the Provincial Youth Council, and;

Whereas, Adults, seek to do anything to protect our youth: to encourage their growth and strengthen their future, and we are called to strengthen the youth leadership, participation, and longevity within our communities, congregations, districts, and province, and;

Whereas, The youth and young adults' desire to be at the forefront of change and growth in the Moravian Church,

Therefore, be it

RESOLVED: (11) The 2023 Synod of the Moravian Church Northern Province encourages the PEC to consult with the Provincial Youth Council on a regular basis and if possible at an annual in-person meeting or video conference.
